GENERAL ADMINISTRATIVE SERVICES:

Levy Proposition

All documents necessary for the August 1 lid lift proposition have been submitted to the County Elections and Assessor's Offices.

FINANCE:

2016 Annual Financial Report

Annual financial reports for CCF&R and Clark 2 have been submitted to the State Auditor's Office. They have been notified we are ready to schedule our 2015-16 financial and 2014-16 accountability audits. The unaudited CCF&R report has been uploaded to the Municipal Securities Rulemaking Board (MSRB) Gateway to meet the continuing disclosure requirements as required by the Security and Exchange Commission (SEC) for our outstanding bond issues. These reports will be updated post-audit. Our Dun & Bradstreet account has also been updated.

Surplus Assets

The 1999 Polaris Ranger sold for \$3,750. The old Vodavi phones sold for \$125 plus \$10 for handling the shipment to a phone reseller in Arizona. Auction fees totaled \$137.50.

FACILITIES & EQUIPMENT:

Station 29

I continue to meet every other week with the contractor, architect and the City of Woodland. The ground work is complete and the metal for the bays should arrive today, (5/08). We've picked a mobile home and are awaiting the second set of drawing for review. The Station Captain has recommended a couple of changes that we will be making.

Station 151

Bids for replacing the roof were due Thursday May 4th. No bids were received. I have called some of the potential bidders to try to find out why and was told they are too busy right now. We will go back out for bid and allow more time for completing the project, the current deadline was October 31st.

Safety upgrades

As previously reported, we have been working on making sure our facilities and apparatus are safe and compliant with L & I rules. I have met with several folks from other departments around the area that have recently gone through an L & I inspection and they have been very helpful in providing information. It is my intent to make sure we are 100% compliant and able to sustain compliance forever. We did receive and install eye wash stations at each station and

flammable liquid cabinets have been ordered. Lists of safety concerns as evaluated by Steve Streissguth and the "dirty dozen" list put out by the WFCA have been distributed to each Station Captain. They are in the process of evaluating their stations to identify issues and to assure all requirements are met. I will keep you informed as we get through this process.

Apparatus decals

With the exception of Medic 29, we have completed replacing the FD 2 and Woodland decals on our apparatus with the CCF&R decals. Each engine also has a decal indicating the city/area they serve.



HUMAN RESOURCES:

Member Updates

Captain Jesse Martin resigned his position with CCFR effective 4/28/17. He accepted a position with Vancouver Fire Department.

Firefighter Ian Fagan was re-hired effective 5/1/17 from the 3 year re-employment list that was created after the lay-offs in 2015.

Disability payment

We received a check from UNUM in the amount of \$21,587.29 for payment of a short-term disability claim. This money goes directly to the District since the employee was on paid leave. The employee will receive a lump sum deposit of hours back into their sick leave accrual bank.

General Operations Update

Flames shot from the roof of a one-story Ridgefield home Saturday morning, catching the eye of someone driving by who quickly called for help.

At about 7:50 a.m., Clark County Fire and Rescue received a call of flames coming from within the home at 21605 N.E. 10th Ave., division chief Tim Dawdy said.

Firefighters quickly arrived on the scene and found flames coming through the roof, Dawdy said. The flames were brought under control within about 20 minutes. Crews from Clark County Fire District 3 and 6 also responded to the call to provide mutual aid.

No one was home at the time and no one was reported injured in the fire, Dawdy said.

"And when we arrived, the smoke alarms were sounding, which we like to hear," he said.

Though the fire was extinguished quickly, Dawdy said the fire did appear to have caused major damage but it did not spread. The home sits back far from the road but is near a business.

"Luckily, there was an alert citizen driving by," Dawdy said.

The cause of the fire is unknown, Dawdy said. The Clark County Fire Marshal's office will investigate.

Flames engulf barn northwest of Battle Ground

flames that stretched more than 40 feet in the air and heard explosions while battling a shop fire Wednesday afternoon northwest of Battle Ground. Clark County Fire & Rescue crews were called to the barn, at the intersection of Northeast 82nd Avenue and Northeast 289th Street, about 1:20 p.m. Wednesday.



Firefighters arrived and saw fire coming through the roof of the roughly 80-by 60-foot barn and called for a second alarm, sending more resources to the blaze, Clark County Fire & Rescue spokesman Tim Dawdy said.

Crews attacked the fire from the outside, Dawdy said. As they fought the blaze, a dump truck

and propane and fuel tanks inside the barn caused explosions.

Janette Chumley said her nephew was welding in the shop.

"He was welding on one of our trucks and a spark went into some waste oil." she said.

The shop houses tools and equipment for her family's excavation business, she said.

Chumley said there's also a sawmill, so the pole barn building stored a load of hardwood slabs placed inside to dry.

Her nephew escaped unharmed, she said. "As soon as he saw the smoke he got out."

Crews brought the blaze under control in about 20 minutes and saved the surrounding buildings, Dawdy said. The barn, however, was a total loss. "It's gone. The whole thing is gone," Chumley said later that afternoon. The family was still piecing together what their next steps would be, she added. Crews from Clark County Fire District 10, Clark County Fire District 3 and Vancouver Fire Department assisted at the scene. The Clark County Fire Marshal's Office was investigating the fire.

Firefighters stayed on the scene for a few hours.

Construction worker injured at Ridgefield job site flown to hospital

A construction worker who suffered serious injuries Friday morning when he fell from the top of a two-story house in Ridgefield was flown via helicopter to a local hospital. The man, identified by Ridgefield police as 55-year-old Rodrigo Baltazar-Martinez, was in critical condition late Friday afternoon, according to a hospital spokesman.

Police and first responders with Clark County Fire & Rescue were called at about 8:45 a.m. to the area of North 35th Avenue and Pioneer Canyon Drive for a man who fell off the roof of an under-construction, two-story house.

Division Chief Tim Dawdy said paramedics began treating the man at the scene but, due to the serious nature of his injuries, activated LifeFlight.

He was flown to the trauma center at PeaceHealth Southwest Medical Center in Vancouver, Dawdy said.



CCF&R SUPPORTS ILANI RESORT OPENING

The ilani Resort opened for business on April 24th, and CCF&R was on hand to help support the grand event. The doors opened to the public at 10:00 AM, but traffic had already backed up on I-5 with thousands of people eager to see the newest destination resort in the region. CCF&R provided an extra crew on duty to help manage any emergencies that



may have occurred. In addition, on duty crews rotated through the site to tour the completed building and get a better understanding of resort operations now that it is up and running. Division Chief Dawdy has been instrumental in working with the contractors and the Cowlitz Tribe to ensure the building and life safety systems were ready for the crowds. CCF&R looks forward to continuing our relationship with the Cowlitz Tribe to ensure the ilani Resort is safe for the four million visitors that are expected each year.

CCF&R BOARD PASSES LID LIFT RESOLUTION

On April 13th the CCF&R Board of Commissioners unanimously passed a resolution to refer a .09 cent/\$1000 levy lid lift to the voters of the Fire District. The lid lift will return the collection rate from \$1.41/\$1000 of assessed value to the previous amount of \$1.50/\$1000. The money raised by the lid lift will be used to initially to staff Fire Station 22 in Charter Oak and to purchase new fire apparatus. In the ensuing years, it will be used for staffing Fire Station 21 at Ridgefield Junction, repairing and replacing critical facilities, ensuring public education programs are provided to the public and schools, replacing worn and outdated emergency equipment, and providing equitable response to underserved areas of the District.

DIVISION CHIEF JACKSON ATTENDS FDIC

DVC Jackson attended the Fire Department Instructor Conference International training conference and expo in Indianapolis with no cost to the District, except for time. Chief Jackson donates his time to assist with the conference, which allows him to attend without the usual registration costs. He is then able to bring valuable information and training materials back to the district for use in training and educating our firefighters. The conference was attended by 33,979 people from 58 nations and over 800 exhibitors spread over 900,000+ square feet of exhibit space.

FIREFIGHTER CUSHWA COMPLETES THE FIRE ACADEMY

Firefighter Matthew Cushwa has completed the Washington Fire Service Training Academy. He and his classmates were honored at a graduation ceremony in Snoqualmie on April 21st. FF Cushwa was presented a Bull Dog Award and named to the 1st-Due Engine Company for his commitment, attitude, and demonstration of superb firefighting skills. Matthew has returned to shift duty and is currently assigned to Station 24 on B-shift.

In other personnel news, Captain Jesse Martin accepted a lateral hire opportunity with the Vancouver Fire Department and started the VFD Academy on April 24th. I want to thank Jesse for his service to CCF&R and for the work he has done to make CCF&R a better fire department. Captain Martin's departure created an opportunity to invite an employee from the re-hire list back to CCF&R. With that in mind, Firefighter Ian Fagan has elected to return. Ian finished with TVF&R and started back with CCF&R on May 1st. He is currently assigned to Station 29 on B-shift.

SIGNIFICANT FIRE AND EMS EVENTS

CCF&R responded to 284 calls for service in April, including two significant structure fires and a serious traumatic injury requiring transport by Life Flight. On April 1st just before 8:00 AM, crews responded to a report of flames from the roof of a house at 21605 NE 10th Avenue. The house sits back from NE 10th and was difficult to see, possibly allowing the fire to grow large before being noticed. Crews brought the fire under control within 20 minutes, assisted by crews from Fire District 3 and Fire District 6. On April 12th CCF&R crews responded to a report of a barn fire at the intersection of NE 289th Street and NE 82nd Avenue. Engine 26 and Battalion 21 arrived shortly after dispatch because they were in the area heading to a drill site to cut up automobiles. They arrived to fine heavy fire and smoke coming from an 80'x60' shop. The fire started when welding slag came in contact with waste oil. Work was being done on a dump truck in the shop. The structure and contents were a total loss, and the homeowner believes the building was not insured. CCF&R was assisted at this fire by crews from Fire District 3, Fire District 10, and the Vancouver Fire Department. On April 28th, Engine 24 and Battalion 21 responded to a report of a person who had fallen from the roof of a house under construction in Ridgefield. Witnesses on scene believed the man was deceased. CCF&R personnel arrived and began treatment. They found a pulse, opened the patient's airway, and provided life-saving airway stabilization and treatment. Due to the severity of the victim's injuries, it was decided to transport the patient by helicopter to the trauma center. Another CCF&R unit was called to the scene to set up a landing zone and assist with transfer of the patient to the Life Flight helicopter. CCF&R was assisted at this event by a crew from AMR Ambulance.
