#### **GENERAL ADMINISTRATIVE SERVICES:**

#### **FINANCE:**

#### **Credit Cards**

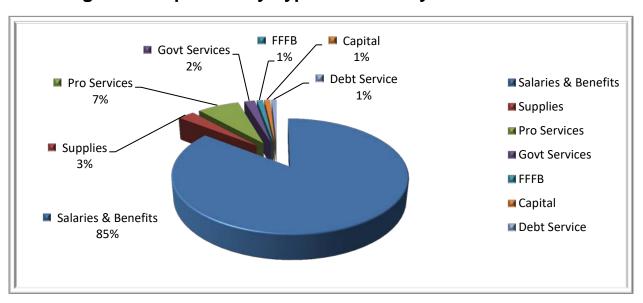

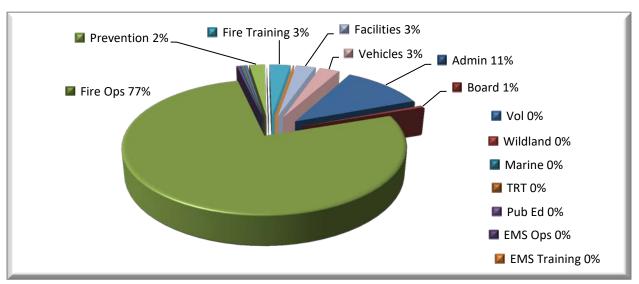

### Percentage YTD Expended by Type\* - as of May 31

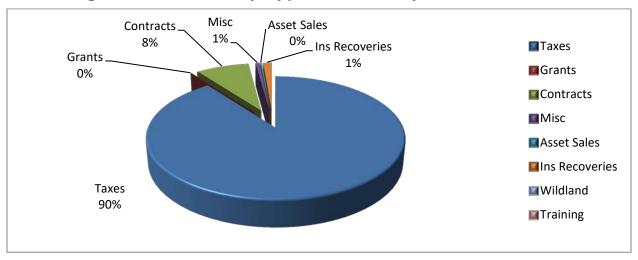


### Percentage YTD Expended by Program\* – as of May 31



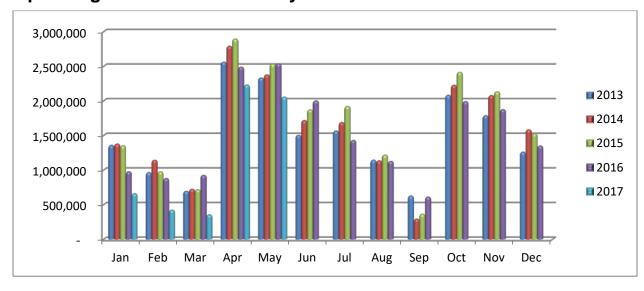

# Percentage YTD Revenue by Type\* – as of May 31

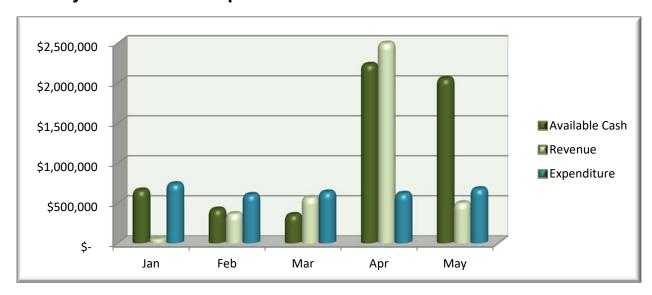

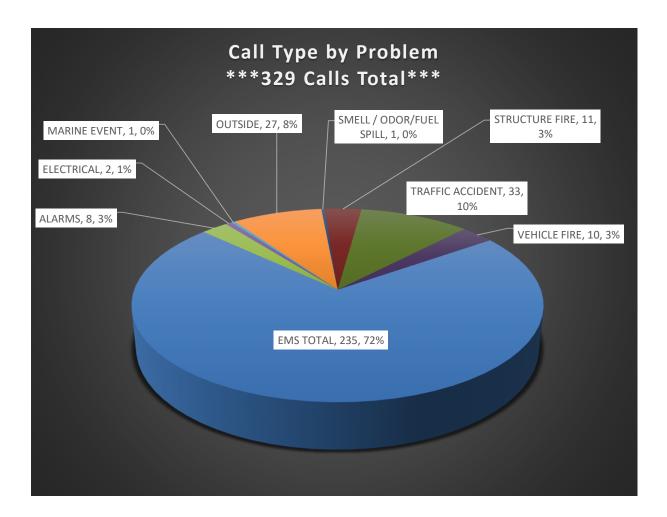
#### **General Operations Update**

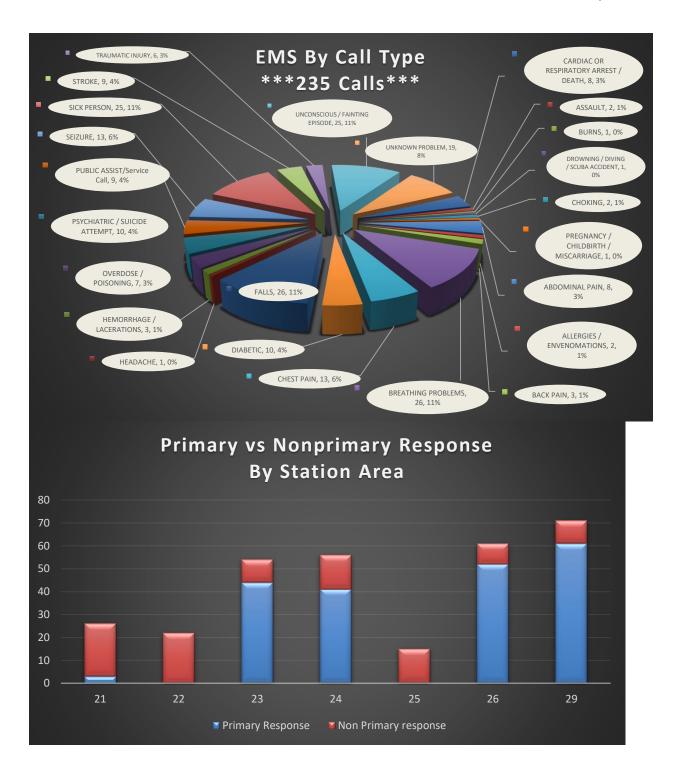
- ilani resort has completed the employee kitchen and dining areas. Inspections and acceptance testing completed by DVC Jackson. The reaming basement space has been bid for completion and work will begin in the coming weeks on the remaining space.
- Station and equipment inspections were completed by Chief Nohr and areas for improvement have been noted for further attention and review at future inspection times.
- On June 7<sup>th</sup>, we switched to the new digital radio infrastructure with CRESA. This transition is now complete and the old radio infrastructure will be removed along with reprogramming of radios to remove old analog talk groups.
- Captain Lawrence has continued participation with the Resource Network for Aging and Disabilities in the County and has initiated discussions with Keiser Health to improve our ability to get patients connected with more diverse resources outside of the emergency room. Keiser has expressed interest in Community Paramedicine programs and proactive home visit programs for target populations to possibly be coordinated with our agency.
- BC Lange has established a list of internal members that have been selected to participate in the peer support program that will receive training this fall as the team is formally established. This group will target peer support for our responders to aid in coping with stress and issues related to traumatic and emergency response.

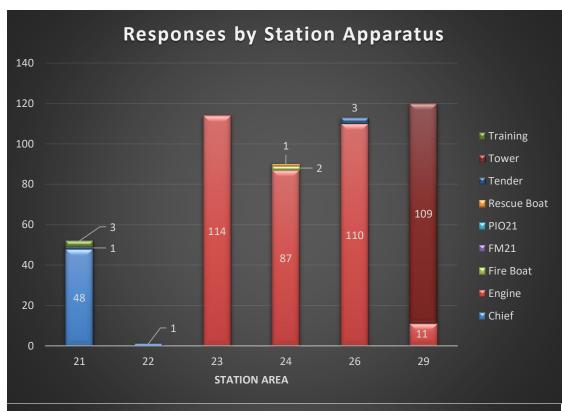

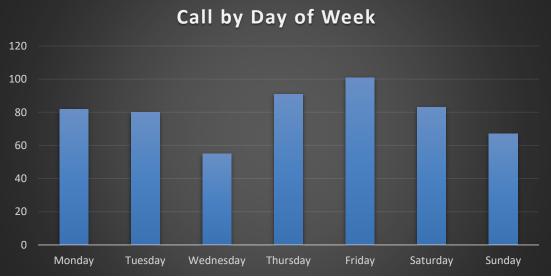


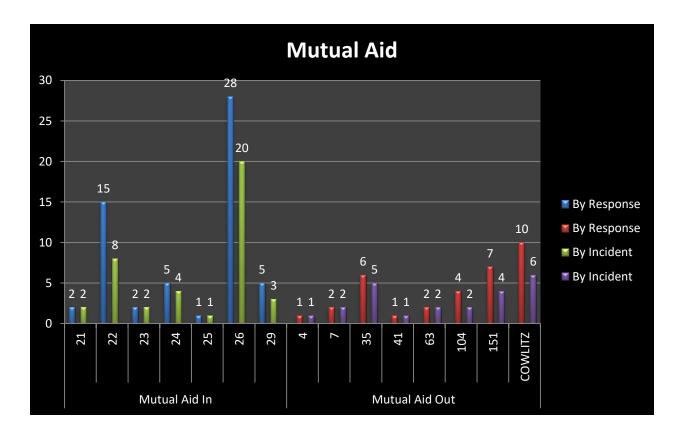












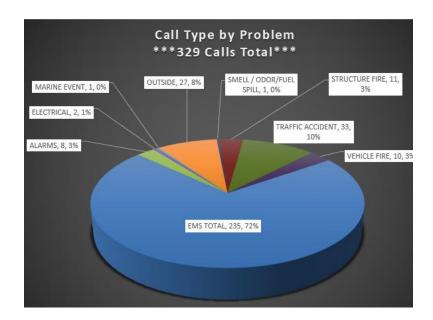


# Monthly Report

#### LID LIFT LEVY

CCF&R continues to prepare for the August 1<sup>st</sup> Lid Lift Levy, which will raise the current property tax rate of \$1.41 per \$1000 of assessed value to \$1.50 per \$1000. Staff has been busy putting together informational flyers, speaking with community members, and interviewing with local media outlets to discuss the issues. If successful, the lid



lift will allow CCF&R to restore 24-hour staffing at the Charter Oak and Ridgefield Junction fire stations, as well as restoring public education programs and performing badly needed facility repairs and upgrades throughout the District.

#### STATION INSPECTIONS

Chiefs Nohr, Jackson and Yager inspected each station and front line apparatus to guarantee operational readiness and high standards of cleanliness and functionality. Chief Nohr has instituted an annual operational readiness inspection program to help ensure that our apparatus and facilities are receiving the care needed to extend their functional lifespan. Chief Nohr noted that the stations and apparatus had been cleaned and prepared to a high standard, but that several of the apparatus and three of the fire stations were beginning to show their age. Even with regular care and maintenance, two of the fire engines will need to be replaced in the near future.

#### **COMMUNITY INVOLVEMENT**

June was a busy month of community involvement for CCF&R. It started with The Big Paddle in Ridgefield on June 3rd, where our Fire Boat guided kayakers, canoers, and stand-up paddle boarders safely out to the Columbia River and back to the Ridgefield Marina. Fire Boat 24 assisted with bringing a wet and cold paddler safely back to shore after he fell from his board. Woodland's annual Planters Days was held June 15-18. CCF&R participated in the parade with Chief Nohr and Cowlitz County FD#1 Chief Denning leading the way. Tower 29 also participated in the parade. Afterward, the CCF&R Firefighter's Association served up 1100 pounds of beef at

the annual Firefighter's Bar-B-Que. Proceeds from the sale of the sandwiches go to Firefighter's Association to help fund purchases and programs throughout the year. A hearty "Thank You" to all of the CCF&R firefighters, staff, and family members who helped out with this event. In addition to The Big Paddle and Planters Days, CCF&R was busy with multiple end-of-school-year field days, which had crews visiting with the students and spraying (literally) tons of water.

#### **EMS DISTRICT 2**

The annual report on our ambulance service contract was presented on June 13<sup>th</sup> by The City of Vancouver Fire Chief Molina, MPD Dr. Wittwer, and AMR Regional Director Rocco Roncarati. CCF&R, Fire District #3, and Fire District #6 make up EMS District 2. Ambulance service to the District is provided by AMR Ambulance through a subcontract with the City of Vancouver. According to the data presented at the meeting, AMR is currently meeting the requirements of the contract. However, Chief Nohr continues to have concerns about the growing length of ambulance response times within CCF&R's area, and the frequency of times that there are no ambulances available to respond (known as Level Zero). Chief Nohr, Chief Wrightson (FD#3) and Chief Green (FD#6) will be meeting with Chief Molina and AMR in July to discuss these concerns. The chart below shows the response times for AMR over the past year. CCF&R falls within the Low Density areas of the EMS District.

#### **CRESA RADIO CUTOVER**

On June 7<sup>th</sup>, we switched to the new digital radio infrastructure with CRESA. This transition is now complete and the old radio infrastructure will be removed along with reprogramming of radios to remove old analog talk groups. The new digital format allows for clearer communications between units, as well as the ability to alert individual radios or groups of radios, similar to a pager. The radio alerting feature will be used by CCF&R to dispatch our volunteer water tender operators to incidents, which will allow us to receive tender credit from the Washington Survey & Ratings Bureau.

#### **CCF&R CADET GRADUATION**

14 local high school seniors graduated from our Cadet program on June 6<sup>th</sup>. This is the 26<sup>th</sup> class to have gone through CCF&R's program. The seniors presented a flag made out of fire hose as their class gift. Each of the 14 graduates will be entering college programs geared toward a career in firefighting and ems or will begin to volunteer as a firefighter.
