#### **Finance Committee**

Commissioner Town reported that the committee met earlier to review the year to date budget as of June 30. A number of time loss injuries have affected the overtime budget and the high number of unexpected apparatus and facility repairs have also had a significant impact on the budget. The injuries have resulted in the to cover roughly 270 shifts, which is about the number of shifts for two full time personnel. 87.5% of the overtime budget has been spent year-to-date. Vehicle maintenance is almost fully spent.

Overall, the budget is about half spent, but some items have not yet been paid (annual expenditures). Commissioner Kolke added that staff is well aware of the issues and working to fix, slow or mitigate impacts to the overall budget.

### **Commissioner Updates**

Commissioner Johnson advised he met the new Woodland Police Chief. Heard good comments shared by the City of Woodland regarding the department and DVC Jackson.

#### **OLD BUSINESS**

Following up on the concern regarding release of personal information following an investigation – Chief Nohr advised that the Public Records Act protects personal information of employees. Only certain information may be released. A community meeting was held on July 22 to share information on the lid lift. Commissioner Bartel, Chief Nohr, and one citizen were in attendance. A second public meeting will occur following the July 27 Board meeting at 6:00 p.m. Staff have taken a number of phone calls to answer citizen questions. Chief Nohr provided an update on the proposed 25 year contract with the City of Woodland. The City has scheduled a workshop on Monday, July 31 at 6:00 p.m. to review the contract. Changes to the contract have been reviewed by the District's counsel and there are no issues. Anticipating there will be a vote at the August 7 regular Council meeting.

Chief Nohr reported in the first 91 days of service there were 68 calls at the ilani Resort.
