A completed announcement document will be provided once all the information is gathered.

Chief Nohr reported that the Hillhurst property purchase has gone to the title company. We are waiting to hear when we need to submit payment. There has been a concern brought up regarding event attendees parking on the easement north of the property and now that the property has been mowed, on the building site. Chief Nohr stated he would go out to the property and take a look to determine different options of what can be done to eliminate problems with the parking issue and the ruts left in the ground.
