## **District Secretary/Chief**

Chief Nohr advised the Hayes Road property is ready to listed for sale/bid. Signs will be posted at the property with bidder information on the website. The Hillhurst Road property purchase is now in escrow. Part of the delay was due to the need to correct the property description to match the County data. Once the purchase is finalized we will move forward with surplussing Station 24. Once we own the property we will be responsible for maintenance (mowing). Noted that the wildfire season has been slow to start. Several IMT members were dispatched to Alaska in the past month. There was a small State MOB to Bickleton. No one is currently deployed.

Chief Nohr provided an update on the hiring process to fill the Lingle retirement vacancy. The lateral list candidate withdrew and all the former full time

employees who were contacted have declined to return. Now contacting former volunteers and interns who are currently employed full time with other agencies. This may enable us to hire a qualified candidate who is already familiar with our jurisdiction. Three candidates will be interviewed on Friday, August 2.

The budget timeline will be presented at the next meeting. The Board was asked to consider budget goals and Chief Nohr will present his suggested goals at the August 9 meeting.

# **OLD BUSINESS/OTHER**

Commissioner Bartel asked if the district has considered membership in the Ridgefield Chamber of Commerce. Discussion. Chief Nohr will look into participation.

Commissioner Lester asked if there is a bid deadline. Chief Nohr advised that a date has not yet been set, but we will probably allow a month. The deadline will be included in the bidding information.

Commissioner Ayers asked about the field behind Station 25. Chief Nohr reported that legal counsel advised it wouldn't be a problem to lease the property under contract. DVC Yager will contact the neighbor who expressed interest in the past. The property will need to be mowed in the interim.
