# WFCA Region VIII Update - Bartel

Commissioner Bartel advised that HB1362 was introduced, which would raise the 101% limitation to 103% and be tied to changes in population. SHB1168, a DNR funding bill is still moving forward.

Commissioner Johnson provided an update on his personal health situation. Added he was very proud of the district and everything it has accomplished over the years. The Board members expressed support and comments on the honor to work with him over the years.

# **CHIEF'S REPORT**

Chief Nohr excused both DVCs Peeler and Yager from the meeting to attend to personal business. An HVAC pump was installed at Station 29. This will eliminate the need for the 3-4 portable air conditioners needed during the summer months. DVC Yager has assembled a packet to advertise for Architectural and Engineering services next month. Will review and may a selection at one of the May Board meetings. Provided a Department of Health vaccination clinic participation update. Received the 2021 Cowlitz Tribe contract payment in the amount of \$346,400, which includes the garage improvements. They will not be making the additional value increase payment this year. Noted they are not obligated to do so under the contract. Notification that the first COVID grant reimbursement has moved through the process and we should receive payment soon. Commissioner Bartel asked when we might meet with the tribe to discuss the new hotel. Chief Nohr advised the hotel will take approximately 2 years to complete so there is plenty of time to meet and discuss. DVC Peeler and Airen Elizabeth are reviewing the impacts of in person meetings as the County moves to Phase 3. Commissioner Bartel advised that FD6 Commissioner Lothspeich is adamant that they do not wish to abandon Station 151.

Chief Nohr added he is honored to have served under Commissioner Johnson and has enjoyed their meetings.
