**RESOLUTION REQUESTING CHANGE OF NAME**

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF CLARK-COWLITZ COUNTY FIRE PROTECTION DISTRICT NO. 15, REQUESTING THAT THE NAME OF THE DISTRICT BE CHANGED TO CLARK-COWLITZ FIRE RESCUE EFFECTIVE IMMEDIATELY.

**WHEREAS**, The City of Woodland annexed into Clark County Fire & Rescue pursuant to a vote of the people in August 2020.

**WHEREAS**, Clark County Fire & Rescue's pre-annexation jurisdictional boundaries were located exclusively in Clark County.

**WHEREAS**, The City of Woodland jurisdictional boundaries are located in both Clark and Cowlitz County.

**WHEREAS**, RCW 52.04.151 requires that a fire protection district located in one county that annexes territory in another county be identified by the name of each county listed alphabetically followed by a number that is the next highest number available for a fire district in the county that has the greatest number of fire districts, which results in the name Clark-Cowlitz County Fire Protection District No. 15.

**WHEREAS**, RCW 52.30.060 authorizes a fire protection district to change its name.

**WHEREAS**, The Board of Commissioners believe that the name of District should be changed to Clark-Cowlitz Fire Rescue; and

**WHEREAS**, RCW 52.30.060 requires approval of the name change by the county legislative authority of the County in which the largest portion of the District is located.


**NOW, THEREFORE BE IT RESOLVED** by the Board of Commissioners of Clark-Cowlitz County Fire Protection District No. 15, Clark County, Washington as follows:


The Board of Commissioners requests that the Clark County Council approve the name change of Clark-Cowlitz County Fire Protection District No. 15 to Clark-Cowlitz Fire Rescue effective immediately upon approval of the Clark County Council.


