# March 24, 2022

Motion by Commissioner Bartel to approve the consent agenda. Second Commissioner Johnson. Commissioner Bartel asked about the PPE rental invoice and the security fencing payment. Chief Nohr explained that due to lengthy lead times and unavailability of proper sizes in existing stock, turnouts had to be rented for the new employees. Regarding the fencing payment, funding from CCSO was already in the account to cover the cost. Streissguth shared it was a partial payment with 5% retainage withheld as required due to the size of the product. There was an \$1,100 change order which has been billed to CCSO. # **Commissioner Updates**

Commissioner Bartel advised he attended the Cowlitz Tribe new engine dedication. Asked why the safety committee information is not public. Advised that personnel issues are discussed, which have tighter public disclosure requirements. Commissioner Chunn commented that the increase in social media coverage is appreciated.

#### **CHIEF'S REPORT**

Chief Nohr shared the tribal gifts received at the dedication to place on display at the station. A traditional cedar headband with abalone shells and an intricate beaded necklace, both crafted by tribal members and a plaque commemorating the event. We also received a white oak tree to plant at the station.

Summarized recent significant call activity. There have been several large fires. Working with the City of Ridgefield and the Port of Ridgefield regarding a second railroad crossing to the marina. Shared a communication from Captain David Greenwood regarding the WSRB water tender test successfully conducted. This will allow FD6 to receive a water tender credit under the recent MOU for tender service. Shared a memo from BC Ryan Berg to recognize Volunteer George Lingle for his assistance in staffing a water tender for an extended period of time during one of the recent fires.

Shared that Captain Blaine Dohman is assisting with our social media management. He has been issued a radio and phone. DVC Jackson is putting together a Public Information Officer (PIO) plan. One employee will be attending a PIO course put on by WSP. Another employee has a background in public information who will be assisting. The goal is to be more proactive in getting messages out to the public.

Commissioner Bartel advised he has a contact in the Ridgefield area who may be interested in helping out with creating videos for the district. Recommended he contact DVC Jackson. Would like to introduce more videos to our social media channels.

Commissioner Bartel advised that Henry Von Dem Fange's memorial service is Friday, March 25 at 11:00 a.m. It will be live streamed on his Facebook page.

Discussed safety issues related to solar panels on personal residences. Concern that the codes haven't caught up with the technology.

## **EMS LEVY - RESOLUTION NO. 220324-1**

Motion by Commissioner Bartel to adopt Resolution No. 220324-1, a resolution authorizing the placement of an EMS levy proposition at the rate of \$0.50 per thousand of valuation on the August 2 primary ballot. Second Commissioner Town.
