STAFF REPORTS

Community Risk Reduction/CARES - Jackson

DVC Jackson detailed CRR and CARES activities for the month of August. Chief Nohr advised that responses to 911 calls under a new program to be funded by Beacon Health Options (BH-ASO) will be bargained with the labor unit.

Operations/Training/Logistics - Peeler

DVC Peeler summarized the August Operations report. New apparatus are in service. Eamonn Ryan was assigned as the Logistics Staff Captain. Robert Harvey was assigned as the EMS Training Staff Captain. Howell, Massie, Lines and Smith completed their one-year probation period.

CHIEF'S REPORT

Chief Nohr summarized the August Chief's report. Exercise equipment purchases are under way thanks to the \$7,500 donation received from the North Pacific Union Conference Seventh Day Adventists. Working on the Woodland asset distribution to CCFR following the annexation. Discussed impact fee funding. Advised E26 was involved in a collision. Estimated \$17,000 repair. Advised crews and the chiefs are attending neighborhood association meetings and remaining active in public events. Advised total of 338 applicants in the pool, 68 lateral, 270 entry level. 30 are paramedics – 12 lateral and 18 entry. SparkHire is being used for pre-recorded video interviews. Working on the budget. Challenges created with the passage of the EMS levy. Estimated revenues are under \$15M for the general fund and \$4.9M for the EMS levy. Working with the chiefs to fine tune the preliminary budget as the asks currently exceed the projected funds. Advised another

meeting may be needed for budget approvals due to cancelled meetings for the Commissioner conference in late October and the Thanksgiving holiday in November. Chief Nohr will provide some date proposals. Will schedule a Finance Committee meeting. Chief Nohr has submitted his name for a vacant City of Camas Council position.

Commissioner Chunn commented he was pleased to see the crews attending Woodland sporting events. DVC Peeler advised when possible the crews attend the sporting events in Ridgefield and La Center as well.

Still looking at ambulance options. Current new build timeframe is 18 months. Hoping to pick up a demo unit. Planning to have everything in place to facilitate a fast purchase should one come up. Supply chain issues with various supplies and equipment are being watched closely.
