## A RESOLUTION REQUESTING THE WASHINGTON STATE DEPARTMETN OF CORRECTIONS TO CONTINUE OPERATIONS AT THE LARCH CORRECTIONS CENTER

**WHEREAS**, Larch Corrections Center (LCC) is slated to be closed by the Department of Corrections in October, 2023; and

**WHEREAS**, LCC is the only correction facility in Clark County, WA the state's fifth largest county. The closure would cause family members to travel further for visitation causing undue stress and increased costs; and

**WHEREAS,** LCC provides valuable education, retraining opportunities and community partnerships for inmates that reduce the recidivism rate of the inmates and provides valuable service to our community; and

**WHEREAS**, many of the employees of LCC live in Clark County and contribute to the area's economic viability; and

**WHEREAS**, LCC plays a vital role in trail maintenance and vegetation control on area recreation lands; and

**WHEREAS,** specifically, LCC trains inmates in critical wildfire prevention and wildfire fighting skills; and

**WHEREAS**, the eastern portion of Clark County consists primarily of vast woodlands susceptible to wildfire that is very challenging to fight; and

**WHEREAS**, the same portion of the county has severely burned several times over the past 125 years, including the Yacolt Burn in 1902 which burned 238,920 acres of timber, and most recently the Nakia Fire last summer that resulted in the evacuation of hundreds of households; and

**WHEREAS**, the growing population in Clark County has pushed housing developments further into said woodlands; and

WHEREAS, LCC inmates provide fast-acting and critical firefighting triage for this area.

**NOW, THEREFORE, BE IT RESOLVED** by the Clark-Cowlitz Fire Rescue Board of Fire Commissioners as follows:

- 1. The Board of Fire Commissioners of Clark-Cowlitz Fire Rescue, which protects the cities of Ridgefield, La Center, and Woodland in SW Cowlitz County immediately adjacent to Clark County on Interstate 5, recognizes the vital role that LCC plays in keeping this community safe from wildland fires and aids in trail maintenance and development of area recreational lands. The Board strongly urges the Department of Corrections to reverse the decision to close Larch Correctional facility.
- The District Secretary of Clark-Cowlitz Fire Rescue is hereby directed to forward copies of this resolution to the offices of the Washington State Department of Commerce, the Governor, and such other offices as applicable.
- 3. This Resolution shall be effective immediately upon its adoption by the Board.
