### **Commissioner Updates**

### **CHIEF'S REPORT**

Staff will be meeting with the Cowlitz Indian Tribe representatives next week to discuss the purchase of the second ambulance. Chief Nohr will be on the panel to speak on wildland fires at the Kiggins Theater on Thursday, February 1. Acknowledged BC Max Konkright. This is his last Board meeting and his last shift is Saturday, January 27. His retirement tapout will occur at 7:00 a.m. on Sunday, January 28. BC Konkright expressed his thanks for an amazing career and to Commissioner (former Chief) Bartel for giving him the opportunity. All wished him well in his retirement. Chief Nohr reported that the district's population is up approximately 1,300 from the prior year. Currently estimated at 51,088.

# **TAX INCREMENT AREAS – UPDATE**

Discussed the house and senate bills currently in legislative committee to modify the tax increment legislation. Includes a proposal to allow the junior taxing districts to opt in partially or fully. Recapped the legislative meetings on Tuesday, January 23 and Wednesday, January 24. Commissioner Bartel shared that Senator Rivers had comments that they (the legislators) made a mistake with the law and need to make corrections. Chief Nohr will contact the Ridgefield Port Director to set up another meeting.
